History of

NILE C. KINNICK HIGH SCHOOL
And Other Military Dependent Schools

MILITARY DEPENDENTS PERMITTED to COME to JAPAN - 1946

In early 1946, the War Department proposed to the Supreme Commander Allied Forces (SCAP), that dependents of military personnel be permitted to come to Japan.

MISSION STATEMENT of "YO-HI" - 1947

The mission of Yokohama American High School is to make sure that all students have the skills necessary to become thoughtful and productive members of society, enjoying a life that is fulfilled and self-assuring. A competent, innovative, and supportive staff will help to ensure this mission by offering a comprehensive and pertinent curriculum in an environment conducive to learning.

YO-HI BLUFF SCHOOL - 1947

Before WWII, the building used for the Yokohama American High School housed a Japanese Girl's Commercial College, and its location was commonly referred to as the "Bluff". In September 1946, the Eighth Army took over the facility and created the Yokohama American School (YAS) with 18 students and 2 teachers. The principal was Major Sidel who remained in that position until November 1947. In the summer of 1947, it was renamed the Yokohama American High School [YAHS] but referred to as "YO-HI". It opened on 15 Sep 1947, and by the fall of that year, it enrolled 165 students and 10 teachers.

NASUGBU BEACH ELEMENTARY SCHOOL - 1947

In Sep 1947, simultaneously with the establishment of the High School, which also included students attending for some "grade school classes", the Nasugbu Beach Elementary School facility (formerly a Japanese School) was opened. It consisted of kindergarten thru 8th grade. It is believed that this school at Area 1 on the "beach" was named in honor of "The Nasugbu Beach" campaign which was the landing of American Forces (11th Airborne, etc) on 31 Jan 1945 at Nasugbu in the province of Batangas, about 55 miles from Manila, Philippines. The history of that Nasugbu building can be traced back to 1924, the year after the great Tokyo earthquake. That year the main building was constructed as a Japanese school but in 1939, was converted into a hospital for Japanese forces. It was located between Area 1 and 2, adjacent to the Bowling Alley, Commissary, and the "Bill Chickering" Theater - south of the "Bluff" location and at the end of the "street car" tracks. The building also was a Japanese School and was one of the few buildings left standing in Naka-Ku when World War II ended. That area was later referred to as the Honmoku Beach area. The school consisted of 26 classrooms, a library, art studio, music room and an auditorium/gymnasium.

SCHOOL NICKNAME - 1947

The first Athletic Director (Coach) at Yokohama American High School was 1st Lt. Lawrence H. Glaab (US Army). Prior to that appointment, he was a member of a non-high school "sandlot" football and baseball association in Ohio, whose team name was the "Red Devils". It was his desire to continue that name at YOHI. In the fall of 1947, his nomination was approved by the principal and the student body by acclamation.

Over the years there have been many images of the "Red Devil" and each rendering or appearance has special meaning to alumni who went to school when "their" image was popular, but collectively all images clearly represent alumni pride, enthusiasm, and just plain "clean" team spirit!

SCHOOL COLORS - 1947

Within weeks after acceptance of the "Red Devils" nickname, the student body voted that the school colors would be red and white. Soon red and white color schemes began to emerge in various forms of dress codes, uniforms, decals and labels, drawings on books and newsletters, etc.

FIRST GRADUATING CLASS - 1948

In June 1948, the first class of 24 students graduated - using "scrounged" US Army parachute material for the "Caps and Gowns" - and the first yearbook was published.

NEGISHI HEIGHTS ELEMENTARY SCHOOL – 1948

A year later, on 20 Sep 1948, further growth brought the opening of a second elementary school, Negishi Heights, with 167 children - kindergarten thru 8th grade. It was a modern 2- story building with 16 classrooms, a music room, auditorium/gymnasium, 2 playgrounds and an athletic field. Attendance at the elementary school continued to increase and, in 1952, the kindergarten moved into a separate building -- and the seventh and eighth grades became the Junior High Department.

SCHOOL NEWSPAPER – 1948

The 1948 Senior Class suggested the name, "YO-HI Echoes", as the name for the school newspaper and it was accepted by the student body. During that era it was published weekly by the students and it echoed the events, thoughts and opinions within the hallowed halls of YO-HI. Gossip, sports columns, fashion articles, and editorials kept the students in contact with the news of the week and provided communications between students, teachers and administration.

ALMA MATER – 1949

In the spring of 1949, the School Administration decided that the best way to create the school's official song by having a contest within the student body, and award a \$25.00 prize to the person who wrote the most appropriate words as voted on by the "administration and faculty". Barbara Farley, Class of 1949, won the contest by writing the words, and selecting the music, for what we now cherish as our Alma Mater.

*In the shadow of Mount Fuji;
Stands our school so dear;
Yokohama High forever,
Sing we loud and clear.
Wide and far though we may wander
As the years go by,
Our love for thee will never falter
Yokohama High.*

*We will love thee
We will cherish
Memories so true,
Of our school; our Alma Mater
Sing we praise of you.*

YO-HI BEACH SCHOOL – 1952

In the summer of 1952, the Yokohama American High School was closed at the "Bluff" location and moved into the existing Elementary School building on "Nasugbu "Beach". It became known as the Yokohama American High School at the "Beach" location. The YO-HI "Beach" location co-existed with the Elementary School in the same facility. Additional facilities were constructed on that property to permit reorganization, and the increase of students. Eventually, the complex consisted of 9 buildings and annexes which accommodated the elementary, junior and high school students.

The original "Bluff" school building was returned to the Japanese in 1952 and demolished, making way for the construction of a new building on that site - called the "Yokohama Girls Commercial School".

SCHOOL MASCOT – 1960

A dog named Akita-san became the school mascot in 1960. The Akita is a strong, independent and dominant breed, commonly aloof with strangers but affectionate with family members. Akita-san roamed the hallways of YO-HI during the day and slept each night in the office of Asst. Principal, Mr. Douglas M. Spaulding, his owner.

"YO-HI" NAME CHANGE to "NILE C KINNICK NAVY DEPENDENTS SCHOOL" – 1960

As the "occupation" era phased out during the late 1950's, the responsibility for the management of most US-controlled facilities in the Yokohama metro area changed from the US Army to the US Air Force and then the US Navy in 1959-1960. During this period, many US military controlled facilities were returned to the Japanese. At the same time the US Navy decided to change the name of the Yokohama American High School and the Negishi Heights Elementary School. The "re-naming" of the schools was done by a Board of Senior Naval Officers who evaluated and selected names submitted by faculty members. Mr. Jim Phillips, Principal at Nasugbu Beach Elementary School submitted the name, "Nile C Kinnick Jr.", to Superintendent Tony Cardinale. Mrs. Primm, Principal at Negishi Elementary, submitted the name for that school, "Richard E. Byrd".

On April 19, 1960, the Yokohama American High School was renamed as the "Nile C Kinnick Jr. Navy Dependents School". It was named in honor of Nile C. Kinnick Jr., the war hero, football player, and Heisman Trophy winner.

YO-HI ECHOES NAME CHANGED to TRIDENT - 1962

In 1962, the traditional "YO-HI Echoes" became a weekly addition to the school's literary material. This one-sheet mimeographed newspaper was included each week in the Navy Housing Bulletin.

There was enthusiasm for something more and a subscription campaign began for a monthly 4-page printed paper, which included pictures, literary efforts by students, and more complete news and feature coverage. A contest was held to determine a name for this new venture and the name "Trident" was selected. The name was especially fitting since it represents the symbol of the "Monarch of the Underworld" or the sea. It was then a Navy school, with a devil for the mascot.

NILE C KINNICK HIGH SCHOOL MOVES TO YOKOSUKA - 1971

In the 1971-72 School Year, after a decline in student attendance, class re-structuring and reassignments, the Nile C Kinnick High School moved from Yokohama to the Yokosuka Navy Base where it is located today. The move from "hama" to "suka" took place in the Fall of 1971, with attendance at Yokosuka beginning after "Christmas Break". After the move from "hama" to "suka", the "busing" situation that had existed for over 20 years now was reversed. Those families living in Yokohama had their children "bussed" to the Yokosuka school. The bussing still exists today - 40+ years later. Ironic!

MIDDLE SCHOOL MOVES to YOKOSUKA - 1980

The "middle" school remained in Yokohama until June 1980, when it moved to Yokosuka. Shortly thereafter, the former Yokohama-based "middle" school building and the other US military facilities adjacent to it (Area 1 and 2 housing, Commissary, PX, bowling alley, Honmoku Beach housing) were returned to the Japanese Government. They were demolished to permit the area to be expanded seaward, by dredging and filling the area with sand. This entire area is now a huge Mall (department store complex) called "MyCal Honmoku", and an industrial and shipping area.
